

BSB51319 DIPLOMA OF WORK HEALTH AND SAFETY

Duration:

Face to Face contact time - 5 days initial interactive class-based workshop (broken into 2 sessions to allow for project completion between block sessions). 6-12 months given for post course research projects.

Distance – self paced assignments to be completed over 12- month duration, resource access and support available.

Recognition of Prior Learning available – discuss with your trainer the RPL option (for blended delivery or full completion).

Who Should Attend:

This qualification reflects the role of individuals coordinating and maintaining the work health and safety program in an organisation. This qualification applies to supervisors and managers who apply a substantial knowledge base and well- developed skills in a wide variety of WHS contexts.

Assessment and Award:

Participants who demonstrate competency by passing all of the theory and practical assessments will receive a 'Qualification' in '**BSB51319 Diploma of Work Health and Safety**' issued by Simpatico Safety Training and Consultancy. Participants who complete individual units will receive a 'Statement of Attainment' for those units completed.

Participants must complete this course within 12 months of course commencement.
